It has come to the notice of EKWMA that the applicants have not complied with the conditions mentioned in the permission for fencing and the proposals submitted by them do not meet the objective of eco-tourism;

The matter has been discussed in the 18th meeting of the EKWMA on 24.02.2012 and in the said meeting it has been resolved that the permission granted for fencing should be cancelled.

In view of above, the permission granted to the applicants in respect of R.S Dag Nos. specified in the EKW area stands cancelled with immediate effect and all the applicants are directed to remove whatever fencing they have done and report to the undersigned within one month from the date of receipt of this order, failing necessary regulatory/legal action will be taken against the applicants.
